The Morris K. Udall and Stewart L. Udall Foundation's (Udall Foundation) enabling legislation includes nine PAS Trustee positions. The Udall Foundation's Board of Trustees has had a total of nine PAS Trustee positions since the agency's inception, even if a position went unfilled for a period of time.

By 10/1994, the United States Senate had confirmed individuals to serve in seven of the nine PAS Trustee positions. (PAS Trustee Position #s 1–7 above.)

By 05/1997, the United States Senate had confirmed an individual to serve in the eighth PAS Trustee position. (PAS Trustee Position #8 above.)

By 04/2003, the United States Senate had confirmed an individual to serve in the ninth PAS Trustee position. (PAS Trustee Position #9 above.)
