 - The Chief Programs Officer, which is a future position, is a direct report to the Executive Director. The Chief Programs Officer's box includes one of its three direct reports:
 - One Grants, Gifts, and Donations Program Manager, which is also a future position.
 - The Director of Education Programs is a direct report to the Chief Programs Officer. The Director of Education Programs' box shows the following direct reports:

 - Two Interns.
 - ❖ The Director of the John S. McCain III National Center for Environmental Conflict Resolution is a direct report to the Chief Programs Officer. The Director of the John S. McCain III National Center for Environmental Conflict Resolution's box shows the following direct reports:

- The Chief Financial Officer is a direct report to the Executive Director. The Chief Financial Officer's box shows the following direct reports:
 - One Senior Accounting Officer
 - One Financial Technician
 - One Contracting Officer
 - One Contracting Officer's Representative and
 - One Contracting Specialist.
